PROPOSED RE-ELECTION OF DIRECTORS PROPOSED GENERAL MANDATES TO SHARE BUY-BACKS AND TO ISSUE NEW SHARES OF THE COMPANY AND NOTICE OF ANNUAL GENERAL MEETING

1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of the resolutions to be proposed at the 2020 Annual General Meeting for (i) re-election of Directors retiring at the 2020 Annual General Meeting; (ii) the granting of the Buyback Mandate to the Directors; (iii) the granting of the Issuance Mandate to the Directors; and (iv) the extension of the Issuance Mandate by adding to it the aggregate number of the issued Shares purchased by the Company under the Buyback Mandate.

2. RE-ELECTION OF DIRECTORS

Pursuant to Bye-law 87 of the Bye-laws, at each annual general meeting, one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office. The Directors to retire in every year shall be those who have been longest in office since their last re-election or appointment but as between persons who became Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. Mr. Chan Wai Kwan and Mr. Francis Goutenmacher, will retire by rotation at the 2020 Annual General Meeting pursuant to Bye-law 87 of the Bye-laws and being eligible, will offer themselves for re-election at the 2020 Annual General Meeting.

Pursuant to Bye-law 86(2) of the Bye-laws and Code Provision A.4.2 of Appendix 14 to the Listing Rules, any Director appointed by the Board to fill a casual vacancy shall hold office only until the next following general meeting of the Company and then be subject to re-election of such meeting. Mr. Tsang Hin Fun, Anthony will hold office only until the 2020 Annual General Meeting and being eligible, offer himself for re-election.

In accordance with the nomination policy of the Company and the objective criteria (including without limitation, gender, age, ethnicity, cultural and educational background, professional experiences and knowledge) with due regard for the benefits of diversity, as set out under the board diversity policy of the Company, the Nomination Committee of the Company has reviewed the re-election of the Directors through:

- (a) evaluating the perspectives, skills, experience, performance and contribution of the retiring Directors that can bring to the Board; and
- (b) assessing the independence of the Independent Non-executive Directors to be re-elected and considered whether they remained independent and suitable to continue to act in such roles.

After due evaluation and assessment, the Nomination Committee is of the opinion that:

- i. all the retiring Directors contribute effectively to the operation of the Board;
- ii. the retiring Independent Non-executive Directors fulfill the requirements of independent non-executive directors under Rule 3.13 of the Listing Rules; and are the persons of integrity and have independent personality and judgement;
- iii. Mr. Tsang has rich financing and corporate and debt restructuring experience and Mr. Goutenmacher has extensive experience and networks in the fashion industry, their skill and experience from different backgrounds is beneficial to the Board; and
- iv. although Mr. Goutenmacher has served the Company for more than nine years, he has clearly demonstrated his exercise of independent judgment and provision of objective challenges and advices to Executive Directors and management team and there is no evidence that length of tenure is having an adverse impact on his independence.

Accordingly, the Nomination Committee has recommended to the Board, and the Board has reviewed and resolved, to propose to re-elect each of the retiring Directors at the 2020 Annual General Meeting.

Brief biographical details of the retiring Directors who offer themselves for re-election at the 2020 Annual General Meeting are set out in Appendix I of this circular.

3. BUYBACK AND ISSUANCE MANDATES

Ordinary resolutions will be proposed at the 2020 Annual General Meeting to approve the granting of new general mandates to the Directors:

- (a) to purchase Shares on the Stock Exchange of an aggregate of up to 10% of the number of issued Shares as at the date of passing of such resolution (the "Buyback Mandate");
- (b) to allot, issue and deal with Shares of an aggregate of up to 20% of the number of issued Shares as at the date of passing of such resolution (the "Issuance Mandate"); and
- (c) to extend the Issuance Mandate by an amount representing the aggregate number of Shares purchased by the Company pursuant to and in accordance with the Buyback Mandate.

The Buyback Mandate and the Issuance Mandate will continue in force until the conclusion of the next annual general meeting of the Company held after the 2020 Annual General Meeting or any earlier date as referred to in ordinary resolutions nos. 7 and 8 set out in the Notice.

As at the Latest Practicable Date, the Company had no immediate plan to issue any new Shares under the Issuance Mandate.

In accordance with the requirements of the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the granting of the Buyback Mandate. The explanatory statement as required by the Listing Rules in connection with the Buyback Mandate is set out in Appendix II to this circular. The Directors wish to state that they will exercise the powers conferred by the Buyback Mandate to repurchase Shares in circumstances which they deem appropriate for the benefit of the Shareholders.

4. 2020 ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

The Notice is set out on pages 16 to 19 of this circular. At the 2020 Annual General Meeting, resolutions will be proposed to approve, inter alia, the re-election of Directors, the granting of the Buyback Mandate and the Issuance Mandate and the extension of the Issuance Mandate by the addition thereto of the number of Shares purchased pursuant to the Buyback Mandate.

A form of proxy for use at the 2020 Annual General Meeting is enclosed with this circular and such form of proxy is also published on the websites of the Company (www.ithk.com) and the Stock Exchange (www.hkexnews.hk). To be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority at the Registrar, not less than 48 hours before the time appointed for holding the 2020 Annual General Meeting or any adjournment thereof. Completion and delivery of the form of proxy will not preclude you from attending and voting at the 2020 Annual General Meeting if you so wish.

5. VOTING AT THE 2020 ANNUAL GENERAL MEETING

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Accordingly, each of the resolutions set out in the Notice will be put to the vote by way of a poll pursuant to Bye-law 66 of the Bye-laws.

6. RECOMMENDATION

The Directors consider that the proposed re-election of Directors, the granting of the Buyback Mandate and the granting/extension of the Issuance Mandate are in the interests of the Company, the Group and the Shareholders as a whole. (1) MR. CHAN WAI KWAN, AN EXECUTIVE DIRECTOR

Experience

Mr. Chan Wai Kwan, aged 49, is an Executive Director of the Company. He is also the Chief Executive Officer of I.T China; a member of the Executive Committee; a director of the joint venture between Galeries Lafayette and the Company; and a director of the joint venture between Kenzo and the Company. Mr. Chan is responsible for the development of the Group's business and operations in the PRC. He joined the Group in January 2006. Mr. Chan has over 25 years' PRC experience gained from multinational companies across fashion retailing, garment sourcing and production sectors. Mr. Chan is a Fellow Member of the Hong Kong Institute of Certified Public Accountants. He holds a Master degree in Business Administration from the University of Hull and a Bachelor's degree of Arts (Honour) in Accountancy from The Hong Kong Polytechnic University.

Save as disclosed above, as at the Latest Practicable Date, Mr. Chan did not have any other major appointments and professional qualifications; has not held any directorship in any other public companies whose securities are listed on any securities market in Hong Kong or overseas during the past three years; and does not hold any other positions with the Company or other members of the Group.

Length of service and emoluments

The Company entered into a service agreement with Mr. Chan as an Executive Director of the Company and the Chief Executive Officer of I.T China commencing on 1 April 2019 for a term of three years (subject to renewal). Under the service agreement, Mr. Chan is entitled to an annual package of basic pay and an annual bonus of an amount as the Board may determine in its absolute discretion in respect of each complete financial year of the Group during his service term. Mr. Chan's current basic pay is of an annual package of HK\$5,307,120. Mr. Chan is also entitled to participate in the Company's share option scheme on such terms as may be determined by the Independent Non-executive Directors from time to time and to all reasonable out-of-pocket expenses. He was an independent non-executive director of South Shore Holdings Limited (formerly known as The 13 Holdings Limited), a company listed on the Stock Exchange, from 2013 to 2020.

Save as disclosed above, as at the Latest Practicable Date, Mr. Goutenmacher did not have any other major appointments and professional qualifications; has not held any directorships in any other public companies whose securities are listed on any securities market in Hong Kong or overseas during the past three years; and does not hold any other positions with the Company or other members of the Group.

Length of service and emoluments

Mr. Goutenmacher served as the Independent Non-executive Director commencing from 1 August 2006 for an initial term of one year and was renewed annually up to 31 July 2020. Mr. Goutenmacher is currently entitled to an annual director's fee of HK\$287,040, which was determined by the Board with reference to the fees paid to independent non-executive directors by other listed companies in the apparel retail industry. Mr. Goutenmacher will also be entitled to all reasonable out-of-pocket expenses. No services contract was entered into with Mr. Goutenmacher.

Relationships

Other than the relationship arising from his being an Independent Non-executive Director, Mr. Goutenmacher does not have any relationship with any other Directors, management team, substantial Shareholders or controlling Shareholders (as defined in the Listing Rules) of the Company.

Interests in Shares

As at the Latest Practicable Date, Mr. Goutenmacher does not have any interest and short position in the Shares or underlying Shares and debentures of the Company and its associated corporations within the meaning of Part XV of the SFO.

Matters that need to be brought to the attention of the Shareholders

Mr. Goutenmacher has been appointed as an Independent Non-executive Director since August 2006. Pursuant to Code A.4.3 of the code provisions of the CG Code, an independent non-executive director having served the Company for more than nine years could be relevant to the determination of his independence. The Board opined that Mr. Goutenmacher has clearly demonstrated his exercise of independent judgment and provision of objective challenges and advices to Executive Directors and the management team. There is no evidence that length of tenure is having an adverse impact on his independence.

There is no information to be disclosed pursuant to any of the requirements of the provisions under paragraphs 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Other than the above, there are no other matters concerning Mr. Goutenmacher that need to be brought to the attention of the Shareholders.

(3) MR. TSANG HIN FUN, ANTHONY, AN INDEPENDENT NON-EXECUTIVE DIRECTOR

Experience

Mr. Tsang Hin Fun, Anthony, aged 60, was appointed as an Independent Non-executive Director of the Company in December 2019. He also serves as a member of each of the Company's Audit Committee, Nomination Committee and Remuneration Committee.

Mr. Tsang started his career in Coopers & Lybrand (now known as PricewaterhouseCoopers) and left after working there for nine years. Since then, he held various senior positions in different companies, including five companies listed on the Stock Exchange. Mr. Tsang is currently the general manager (corporate) of a private group engaged in production of timber products, a senior consultant of China Eco-Farming Limited, which is listed on the Stock Exchange, and the managing director of a consultancy firm advising on corporate and debt restructuring for clients of major banks in Hong Kong. He was an independent non-executive director of Alpha Professional Holdings Limited (formerly known as Z-Obee Holdings Limited) from August 2014 to November 2017, which is listed on the Stock Exchange.

Mr. Tsang holds a Master of Business Administration Degree from the City Polytechnic of Hong Kong (now known as City University of Hong Kong) and is a fellow member of both the Hong Kong Institute of Certified Public Accountants and the Association of Chartered Certified Accountants. He has been a member of the Finance Sub-committee of the Hospital Governing Committee of Tuen Mun Hospital since 2010 and a member of the Hospital Governing Committee of Tin Shui Wai Hospital since 2016.

Save as disclosed above, as at the Latest Practicable Date, Mr. Tsang did not have any other major appointments and professional qualifications; has not held any directorships in any other public companies whose securities are listed on any securities market in Hong Kong or overseas during the past three years; and does not hold any other positions with the Company or other members of the Group.

Length of service and emoluments

Mr. Tsang served as the Independent Non-executive Director commencing from 2 December 2019 for an initial term of one year up to 1 December 2020. Mr. Tsang is currently entitled to an annual director's fee of HK\$287,040, which was determined by the Board with reference to the fees paid to independent non-executive directors by other listed companies in the apparel retail industry. Mr. Tsang will also be entitled to all reasonable out-of-pocket expenses. No services contract was entered into with Mr. Tsang.

Relationships

Other than the relationship arising from his being an Independent Non-executive Director, Mr. Tsang does not have any relationship with any other Directors, management team, substantial Shareholders or controlling Shareholders (as defined in the Listing Rules) of the Company.

Interests in Shares

As at the Latest Practicable Date, Mr. Tsang does not have any interest and short position in the Shares or underlying Shares and debentures of the Company and its associated corporations within the meaning of Part XV of the SFO.

Matters that need to be brought to the attention of the Shareholders

There is no other information to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules, and there are no other matters concerning Mr. Tsang that need to be brought to the attention of the Shareholders.

The following is an explanatory statement required by the Listing Rules to be sent to the Shareholders to enable them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the 2020 Annual General Meeting in relation to the granting of the Buyback Mandate.

1. REASONS FOR SHARE BUYBACK

The Directors believe that the granting of the Buyback Mandate is in the interests of the Company and the Shareholders as a whole.

Buy-back of Shares may, depending on the market conditions and funding arrangements at the time being, lead to an enhancement of the net asset value per Share and/or earnings per Share. The Directors are seeking the granting of the Buyback Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be purchased on any occasion and the price and other terms upon which the same are purchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

2. SHARE CAPITAL

As at the Latest Practicable Date, the issued shares of the Company comprised 1,195,797,307 Shares.

Subject to the passing of the ordinary resolution no. 7 as set out in the Notice in respect of the granting of the Buyback Mandate and on the basis that no Shares are issued or purchased by the Company prior to the date of the 2020 Annual General Meeting, the Directors would be authorised under the Buyback Mandate to purchase a maximum of 119,579,730 Shares (representing 10% of the number of issued Shares as at the Latest Practicable Date) during the period in which the Buyback Mandate remains in force.

3. FUNDING OF PURCHASES

In purchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the memorandum of association, the Bye-laws, the laws of Bermuda and/or any other applicable laws.

The Company is empowered by its memorandum of association and the Bye-laws to purchase Shares. The laws of Bermuda provided that the amount of capital paid in connection with the share purchase by a company may only be paid out of either the capital paid up on the relevant shares, or the funds of the company which would otherwise be available for dividend or distribution or the proceeds of a fresh issue of shares made for such purpose. The amount of premium payable on purchase may only be paid out of funds of the company which would otherwise be available for dividend or distribution or out of the share premium account of the company before the shares are purchased.

4. IMPACT OF PURCHASES

There might be material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited consolidated financial statements contained in the annual report for the year ended 29 February 2020) in the event that the Buyback Mandate was to be carried out in full at any time during the proposed purchase period. However, the Directors do not intend to exercise the Buyback Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. TAKEOVERS CODE

If as a result of a buy-back of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in voting rights as a result of any share buy-back, could obtain or consolidate control of the Company and become(s) obliged to make a mandatory offer under Rule 26 of the Takeovers Code.

To the best knowledge of the Company, as at the Latest Practicable Date, based on the disclosure under Part XV of the SFO, HSBC International Trustee Limited as the trustee of The ABS 2000 Trust (which amongst others, Mr. Sham Kar Wai and Mr. Sham Kin Wai, Executive Directors, are beneficiaries) was interested in 698,564,441 Shares, representing approximately 58.41% of the issued Shares. In event that the Directors exercise in full the power to buy-back Shares in accordance with the terms of the relevant ordinary resolution to be proposed at the 2020 Annual General Meeting, then (if the present shareholdings otherwise remained the same) HSBC International Trustee Limited's interest would be increased to 64.90% of the issued Shares.
